**GOV. RICK SCOTT REAPPOINTS JACKSONVILLE
ATTORNEY CHRISTOPHER COBB TO FLORIDA
CONSTRUCTION INDUSTRY LICENSING BOARD**

Jacksonville, Fla. – December 30, 2013 – Last week, Gov. Rick Scott reappointed Jacksonville attorney and Jimerson & Cobb partner Christopher Cobb to a second term on the Construction Industry Licensing Board (CILB).
