**Jimerson & Cobb, P.A. Earns Place on Jacksonville Business Journal's
50 Fastest Growing Companies for Fifth Consecutive Year**

JACKSONVILLE, Fla. (July 20, 2017) – Jimerson & Cobb, P.A. earned a coveted place on the Jacksonville Business Journal's list of 50 Fastest Growing Companies ranking 26th overall with a revenue growth of 35 percent, and is the only law firm to make the list for five consecutive years.

To qualify for the list, the firm needed to meet several criteria. In addition to being a privately held and locally owned for-profit business, companies also had to report total revenues of at least \$1 million in 2016 and show revenue gains in the previous three years. Ennis, Pellum & Associates, a local accounting firm, was responsible for determining the rankings based on each nominated company's percentage of annual growth over a three-year period.

"The main factor contributing to our firm's growth is our exceptional employees," said Managing Partner Charles B. Jimerson. "This award is a testament to the hard work and dedication our employees put forth to not only take care of our clients by providing quality service and results, but the firm itself, which is especially important as we strive to remain consistency while growing so rapidly."

In an interview with the Jacksonville Business Journal, Jimerson notes the most surprising thing about the company is "we never underestimate the importance of having fun."
