The survey also included two open-ended questions and seven demographic questions, which focus on these eight themes: Leadership and planning; corporate culture and communications; role satisfaction; work environment; relationship with supervisor; training and development; pay and benefits; and overall engagement.

This year, Jimerson & Cobb moved up significantly in the rankings, going from 17<sup>th</sup> in 2017 to 6<sup>th</sup> in 2018 of Best Small Companies with 15 to 49 employees.
